## Terms and Conditions

The following are a summary of our 'need to know' terms and conditions and payment and cancellation policy. A full terms and conditions document can be provided upon request.

### 1: Event details and booking confirmation

- 1.1 Confirmed bookings are established on receipt of the specified non-refundable deposit. The initial deposit is payable within 10 working days of the date request. Should we not receive the initial deposit within the specified time, we reserve the right to cancel the booking.
- 1.2 Deposits are not refundable under any circumstances or time periods. Therefore please be very certain before paying your deposit. The confirmation deposit is deducted from your final account.
- 1.3 A minimum reservation notice period is required as follows:
  - a. 2 working days for groups of 10-30 guests
  - b. 5 working days for groups of 31-50 guests
  - c. 10 working days for groups of 51-73 guests
  - d. 15 working days for groups over 73 guests

### 2: Payment

- 2.1 Hurakia will issue an invoice to the client for a non-refundable deposit amounting to 33% of quoted costs to confirm and reserve the date for the client. The deposit will be deducted from the Client's final account.
- 2.2 A 10% surcharge to Hurakia's total fee applies for events on public holidays as defined in the Holidays Act 2003
- 2.3 All costs are quoted in and payments must be made in New Zealand dollars
- 2.4 Payment for all groups reserving on minimum reservation notice basis is required in full at time of reservation.
- 2.5 Payment for reservations made outside the minimum reservation notice period require payment of the Non-refundable deposit upon confirmation of date, and remaining 67% of full quoted cost of activity 20 working days from date of activity.

### Terms and Conditions

#### 3. Cancellation

- 3.1 Cancellation of reservations that fall within the minimum reservation notice period for groups 'a' and 'b' will be charged a cancellation fee amounting to 100% of the estimated total event costs.
- 3.2 Cancellation of reservations that fall within the minimum reservation notice period for groups 'c' and 'd' must be made prior to 5 working days to the date of the activity. A cancellation fee amounting to 50% of the estimated total event cost will be charged. Cancellations made in 5 working days or less will be charged a cancellation fee amounting to 100% of the estimated total event cost.
- 3.3 Cancellation of reservations made outside the minimum reservation notice period will incur the following cancellation fee:
  - 10 working days from date of activity 50% of estimated total cost
  - 5 working days from date of activity 100% of estimated cost
- 3.4 The date of the event may be postponed to another available date if the date is available and the client gives Hurakia at least 20 days' notice in writing. If notice of postponement is less than 20 days but more than 10 days the non-refundable deposit will be deemed to be forfeited by the client and a second deposit will be required to secure the new date. Postponement of 10 or less working days' notice will be deemed to be a cancellation and cancellation fees in clause 3.3 will apply
