Terms and Conditions

1. Booking details and confirmation

- 1.1. All rates include 15% GST. A confirmation deposit of 50% is required at time of booking. The remaining 50% of the full tariff is payable in full 30 working days from the date of booking.
- 1.2. Check-in is at 2pm, check-out at 11 am.
- 1.3. Rates are quoted in New Zealand dollars and charged on a per person, two night minimum stay basis.
- 1.4. Rates are subject to confirmation at the time of reservation.
- 1.5. Children five years and under stay free of charge, when staying with their parents in the same suite. Only one child permitted per suite.
- 1.6. Rates for children are available on request.
- 1.7. Notice of all special dietary requirements is required at time of reservation and meal costs may vary from those advertised. If guests require meals to be produced during their stay which are different from those agreed on in advance, Hurakia, due to its isolated location, cannot guarantee that it will be able to supply such different meals at the guest's request.
- 1.8. No stiletto heels to be worn inside the lodge as they can severely damage the wooden floors.
- 1.9. No children (under 14 years old) to be left unattended in any buildings or on the grounds. All children must be fully supervised by a parent or guardian at all times.
- 1.10. No candles or open flames are allowed in any buildings.
- 1.11. There is a designated smoking area on-site, smoking is strictly prohibited in any other part of the venue.

2. Cancellation

- 2.1. The deposit In the event that Hurakia Lodge is unable to replace a cancelled reservation, the following applies:
- 2.2. 50% of the total cost will be charged, if a reservation is cancelled between 7 and 21 days prior to arrival.
- 2.3. Should cancellation be received within seven days prior to arrival, a 100% charge for every night cancelled will be applied.
- 2.4. "No shows" will be charged at 100% of the applicable rate, for the total stay.
- 2.5. Between 15 December – 15 January, a cancellation made 60 days prior to arrival includes a 50% cancellation fee for each night cancelled. A cancellation within the same period, made 30 days prior to arrival, incurs a 100% cancellation fee

3. Insurance and no liability

- 3.1 The personal effects of the guest will not be insured by the Owner/Property Manager. The guest acknowledges that all personal items remain the guest's responsibility and the Hurakia Ltd accepts no responsibility for loss or damage.

- 3.3 Children are to be supervised at all times by a parent or responsible adult.

4. Left Property

- 4.1 Personal items left behind at the property will be held for 30 days from the guest's departure date. The guest agrees they will contact Hurakia Ltd within 30 days of departure if they would like items returned.
- 4.2 An administration fee of \$15.00 plus the cost of postage and packaging fees will be charged for shipping and handling.
